- 2.6 The Second Party will actively engage to help the delivery of the training and placement of students of the First Party into internships/jobs.

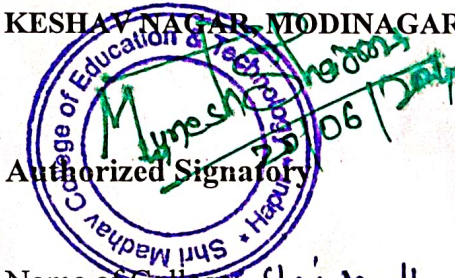
Clause 3 VALIDITY



9. The purpose of this MOU is only to explore & express the intentions of the parties and does not have legal implications.


10. The financial assistance, transportation, hospitality and program planning must be done with good communication between both parties.
